 **Classes:** The chorus @ MATES is divided into three groups. Kindergarteners and first graders meet on Tuesdays from 1:35 pm - 2:20 pm. Classes begin on Jan. 28th and run until the first week of May. Rehearsals will be held in the music room.

 **Instructor:** Mr. LaGuardia has taught chorus and classroom music in the Conejo Valley for the past 20 years. He also teaches at California Lutheran University and is the Elementary Chorus Coordinator for the Arts Council of Conejo Valley.

 **Fees:** To join the Spring Chorus, a payment of \$125 dollars is due by Tuesday, Jan. 28rd 2020. This fee also includes one \$10 ticket to the All District Chorus Festival.

 **Pickup:** Parents must park on La Granada Dr. and walk to the front of the school for pickup. Parents will not be allowed to park in the teacher parking lot during chorus pickup.
